New Business

- Dawn Ahner has found a new software to manage SCDCTA membership information. The software is \$325 for a 10-license package, we would purchase the latest version of File Maker Pro. Cindy Waund motions that we purchase this new software, Pamela Jefcoat seconds, board passes.

Old Business

2007 SCDCTA Changes (Non-Profit Status)

- Valerie Swygert reported that all she found was paperwork where we filed for tax exemption many years past but could not find any recent documentation. Valerie turned over all the information pertaining to this subject to accountant to see at what status we are at currently. The main question was how much can we actually have in holding and still be considered a 'non-profit' organization.

USDF Show

- Rebecca Housely reported that there is a \$65 recognition fee for the USDF as well as supplying them with prize list, qualifying fees, and liability insurance.
- USEF requires a \$75 recognition fee.
- Rebecca reported an example of numbers, board discussed fees and cost.
- The topic of a software package for the show was brought up but that this software does not split AA and Open. Pamela Jefcoat thinks we should consider this software.
- Dru Brunson says there is a handbook that aids in putting on a recognized show and we should consider using this.
- Rebecca Housely is worried about the date of March 24 & 25 being in conflict with other major recognized shows.
- The board threw out a name for the show to be thinking on "Low Country Classic"
